Bill No. 2023-05 Ordinance No. 939; An ordinance amending the Wage and Salary Ranges for the employees of the City of Gerald, Missouri. Mayor Koepke read the ordinance by title for the first time. No discussion. Mayor Koepke read the ordinance by title for the second time.

Alderman Novotney motioned to accept the reading. Alderman Schoenfeld seconded the motion. Upon roll call, the voting was as follows: Alderman Via "aye"; Alderman Guerrant "aye"; Alderman Schoenfeld "aye"; and Alderman Novotney "aye". Bill No 2023-05 was approved and will become Ordinance No 939.
