#### AGENDA APPROVAL

Alderman Via motioned to accept the current agenda. Alderman Parker seconded the motion. All Aldermen voted "aye". Motion carried.

#### WORKSHOP

City Administrator Grube presented the 2026 General Budget to the board. The budget was reviewed by the board. Discussed the differences in the Workman's Comp budget line.

The 2026 Police Budget was introduced and reviewed by the board. Chief Helton explained that he has had no luck finding a potential fifth officer, so he would like to send a potential officer to the police academy, then hire them full-time post-academy. Chief Helton also notified the board of a \$2,500 donation that will be included in the income on the final draft of the 2026 Police Budget.

The 2026 Water Budget was introduced and reviewed by the board. City Administrator Grube explained that the income for water and sewer in 2026 is based on the minimum expected income via water and sewer base rates because of the rate increase.

The 2026 Sewer Budget was introduced and reviewed by the board. City Administrator Grube reiterated that the minimum expected income is based on sewer base rates. He also stated that he has no plans to use anything out of Sewer Reserves, however, issues may arise throughout the year, but hopefully not.

The 2026 Park Budget was introduced and reviewed by the board. City Administrator Grube explained that the biggest expected expense would be maintenance, as the oldest playgrounds will need painted amongst other maintenance tasks throughout the parks.

The 2026 Street Budget was introduced and reviewed by the board. City Administrator Grube reminded the board of the 1% tax that has sunset as of December 31, 2025. Discussed restructuring payroll percentages. Discussed allocating \$20,000 for a new vehicle.
